Private Pool Party renters and their guests must comply with all of the Rules & Regulations set forth by the LK Swim School Inc., LK Lifeguards, Staff & Security

Party deposits are non refundable. In the case that you must cancel, please notify L.K. Staff asap. Your party may be rescheduled to a further available date or the Renter will forfeit the security deposit. The deposit will be credited toward the final party balance. The final party balance is due with 14 days from the party date. Failure to pay on time will result in the credit card on file being processed.

***LKSA Lifeguards are mandatory.** The number of Lifeguards will be determined solely upon L.K.S.A.'s discretion. Factors may include: Amount of participants, the average child age and the amount of child supervision. Additional Lifeguards cost extra. If the number of children at the party surpasses the number originally approved and discussed, the renter may be charged for the cost of an additional Lifeguard for the duration of the party.

Each Child must be accompanied by a responsible adult. At time of admission, each parent must submit or sign a **Party Release Form**. Parents are responsible for supervision. **If any child is NOT water-safe, an adult MUST accompany that child in the water at all times.**

Arrival time for your upcoming party is **no earlier than 45** minutes before the beginning of your party & **timely departure is required**. This includes time cleaning & time spent in the showers and locker rooms. Guests must exit the LKSA facility at or before the pre-arranged end-time of the party. Late departures will result in "additional time fees."

If you wish to provide your own **entertainment OR catering services**, please request approval at the time your party is being confirmed. There are no live animals, no paint and no confetti allowed. **No tape or decorations are to be attached to the walls.**

Any damage done to the LK Swim School Inc. facility or WJCC property shall be billed to the client for either repair or replacement. The LK Swim School Inc. & WJCC are not responsible for the renter's or their guest's personal property.
